## **Categories of Membership and Entitlements**

### **Social Non-Bowling Membership**

Social Members are entitled to entry to the Clubroom and to use the Bar, TAB, Pool and Darts facilities. This category also includes entitlement to attend social functions and events such as Bingo. Social Members are not entitled to vote or Propose or Nominate new Members or Notice of Motions to a Club Meeting.

### **Restricted Bowling Membership**

This category of Membership includes all the entitlements of Social Membership but also permits Members to use the full bowling facilities of the Club and to participate in Club bowling competitions which do not require the wearing of Whites or Club Colours. Restricted Bowling Membership does not entitle Members to play Pennants. Restricted bowling fixtures are mainly during the close season (April to August) but are limited during the main bowling season. Restricted Bowling Members are not entitled to vote or Propose or Nominate new Members or Notice of Motions to a Club Meeting.

### **Full Bowling Membership**

This category of Membership entitles Members to participate in all Club events and functions, bowling or otherwise. Only full bowling members are allowed to vote in any Club elections, to hold office and to wear Club colours. The fee includes the Capitation fee to Affiliate with Bowls WA.

### **Junior Membership**

Junior Members are entitled to play in all Club events and functions bowling or otherwise. Junior Members are not entitled to vote or Propose or Nominate new Members or Notice of Motions to a Club Meeting.

## **CODE OF CONDUCT**

The Eaton Bowling and Social Club Inc. pledges itself to responsible server practice and to avoid disturbing the amenity of the local area by respecting the rights of neighbours and by encouraging members to do the same.

The Management Committee has the full power to suspend or exclude any Member who, in the opinion of the Committee:

1. Is found guilty of discrediting the reputation of the Club.
2. Fails to maintain an acceptable standard of dress.
3. Displays unruly and/or drunken behaviour.

Once a Member or Guest has been identified as becoming intoxicated under the Terms of the Licensing requirements of the Club, staff will limit, and if necessary stop serving that person.

Any person under the age of 18 years is not allowed access to the Bar area.
